

## Student Parking Agreement North Hagerstown High School

Parking on campus is a privilege granted to those junior and senior students who are academically and behaviorally eligible to participate in and attend extra-curricular activities. Therefore, you will be required to agree to the following understandings.

- Students will be expected to give us the license plate number of the car they will most frequently drive to school.
- Consideration is given to those students who are; in diversified occupations, are out of district, participants of extra-curricular activities, and in the Essence Program at H.C.C
- All vehicles parked on school property during the school day must display their parking permit on their rearview mirror.
- All vehicles will be assigned a number for each semester.
- Parking permits are not transferable between students and/or vehicles.
- A fee of \$25.00 per semester will be charged for each parking permit. Students will need to reapply for a permit at the end of the fall semester. **Fees are non-refundable.**
- Cars parked in non-designated parking areas or without a permit to park on grounds may be towed at the student/parents expense.
- Students that violate the parking policy twice may be made conduct ineligible.
- After a student vehicle has been driven into the student parking area, it may not be entered or moved until after school unless prior permission has been obtained from the school administration.
- No loitering in cars will be tolerated during the lunch period or at any time during the school day.
- Reckless driving is prohibited on the school grounds at all times. Drivers must adhere to the speed limit. Squealing tires and loud radios are not permitted.
- The school is not responsible for theft or damage to any vehicle or its contents while it is parked on school property.
- Permission to drive and park on school property will be revoked by the school administration for failure to obey the aforementioned regulations and/other just cause as determined by the administration.
