Introduction:

At its April 3, 2018, public business meeting, the Washington County Board of Education (the “Board”) issued a Charge to its Facilities and Enrollment Advisory Committee (FEAC) to “develop a new attendance zone for the anticipated opening of the Sharpsburg Elementary Replacement School which includes recommendations for long-term enrollment relief at Boonsboro Elementary School and other adjacent schools as needed.”

The Work of the FEAC:

In order to discharge its responsibilities for this part of the Charge, the FEAC met six (6) times over 10 months, reviewed eight (8) possible attendance zone realignments for Washington County Public Schools (WCPS), and presented a progress report to the Board on November 13, 2018. Following the November 13, 2018, presentation, the FEAC met on December 12, 2018, and reached unanimous consensus to recommend three (3) attendance zone realignments. The FEAC presented their recommendations to the Board on February 19, 2019.

I have carefully reviewed the document provided by the FEAC entitled, “Recommendations for a New Sharpsburg Elementary Attendance Zone.” The FEAC members reviewed each of the required factors set forth in Board Policy JCA and followed the Charge provided by the Board.

I have set forth below, the comments and the rationale provided by FEAC in support of their recommendations.

Superintendent's Report:

I am pleased to accept the Report provided by the FEAC. I fully endorse the Report and FEAC's recommendations #1 through #3 listed below. It is imperative that WCPS provide our students with the very best learning environment. The assignment of students from schools that are over-enrolled to a school that will have available enrollment capacity allows for an improved teacher-to-student ratio and may provide opportunities for future pre-kindergarten program expansion. Such action will benefit our students.

- Boundary Realignment Recommendation #1: Reassign approximately 11 K-5 students from the Boonsboro Elementary attendance zone to become part of the new Sharpsburg Elementary attendance zone. This realignment is recommended to take effect at the beginning of the 2020-2021 school year and in conjunction with the opening of the new Sharpsburg Elementary.
- Boundary Realignment Recommendation #2: Reassign approximately 101 K-5 students from the Boonsboro Elementary attendance zone to become part of the new Sharpsburg Elementary attendance zone. This realignment is recommended to take effect at the beginning of the 2020-2021 school year and in conjunction with the opening of the new Sharpsburg Elementary.
- Boundary Realignment Recommendation #3: Reassign approximately 18 K-5 students from the Pleasant Valley Elementary attendance zone to become part of the new Sharpsburg Elementary attendance zone. This realignment is recommended to take effect at the beginning of the 2020-2021 school year and in conjunction with the opening of the new Sharpsburg Elementary.

Superintendent's Request of the Board:

The next step in the process is to arrange for the dissemination of a hard copy of the Superintendent's Report and the FEAC's Report to the schools affected by the proposed changes in the attendance zones (Boonsboro Elementary, Pleasant Valley Elementary, and Sharpsburg Elementary) and to direct principals to make the reports available to parents, students, and community members for their review. Additionally, I will request the Communications Officer to use available electronic means to provide access to the reports as well. The Communications Officer will additionally use the local newspaper, social media, WCPS' website, and other means to provide public notice of these proposed changes.

A public hearing needs to be scheduled by the Board to receive comments from parents and residents with respect to this report and the FEAC's Report. Board Policy Regulation JCA-R requires that the Board vote for any change in attendance area(s) to

be made and announced at least ninety (90) days prior to the effective date of implementation. In order to provide affected students and residents sufficient time to prepare for any potential changes, I am proposing the following schedule for your consideration for both the public hearing and potential vote on the recommendations:
