#### **MEETING MINUTES**

Facilities Enrollment Advisory Committee Meeting

December 6, 2023

#### **Committee Members Present:**

Summary of the Discussion of the Facilities and Enrollment Advisory Committee:

I. Review of AgendaStaff reviewed the Agenda with Committee.

### II. Review of the September 2023 Enrollment and Free and Reduced Meal Eligibility Rates

#### **Enrollment Changes**

Staff reviewed the overall enrollment changes by grade level for the periods ending September 2022 and September 2023. It was noted that there were two (2) scenarios that changed enrollment. The first is "roll-over", where a small/large exiting grade is replaced by a larger/smaller incoming grade, which creates an increase/decrease in students. For example, 100 5th graders exit an elementary school (graduate to middle school) from the prior year, and the new incoming Kindergarten class is only 75 students. The school would see a decrease of 25 students. The second is migration, where students come in or go out of a grade level. For example, the 2nd grade class last year (2022) had 100 students, and the 3rd grade class this year (2023) has 125 students, which resulted in an enrollment increase of 25 due to in-migration. The overall K - 5 enrollment increased by 175 students, which staff noted was a little higher than originally anticipated. Middle school (grades 6-8) enrollment was up by 24 students, and high school (grades 9-12) enrollment was up by 7 students when compared to September of 2022. Overall K -12 enrollment increased by 192 students, and Pre-K-12 enrollment increased by 252 students. Staff noted that the final 2023 enrollment came in just a little higher than what was projected last Spring.

Staff reviewed individual elementary, middle and high schools and focused on those that had the highest change in prior year enrollment and noted the resultant causes of the changes for these facilities. Staff will continue to review new developments, rental housing, or other demographic conditions that may continue to influence enrollment changes. Utilizing GIS software allows staff to geocode students to specific address points to determine what areas are producing the most significant change to the prior year enrollment.

It was noted that Boyd J. Michael, III Technical High School (Tech High) students are no longer recorded at Tech High for State reporting purposes. For the enrollment presented to the State, those students are now reported to their respective home high school, which is different than prior year practices. Staff shared the enrollment numbers presented to the State, and presented a document that showed the Tech High students reported at Tech High, in a traditional format. It was noted that Tech High has seen an increase of 40 students primarily based on the Cosmetology Program enrolling 10<sup>th</sup> grade students to allow for meeting state training requirements and the recently added Diesel Program is now in its 2<sup>nd</sup> year thus having enrollment in both grade 11 and 12.

#### **Student Enrollment Trends**

Trends by grade level show that enrollment levels are slowly returning to pre-pandemic levels. Staff noted that despite the dip caused in part by the pandemic, overall enrollment continues to exhibit slow but steady growth year to year, over the past 20 years.

#### **Committee Member Discussions**

A Committee member noted that any student enrolled at Barbara Ingram School for the Arts (BISFA) who wishes to take part in high school sports must do so at South Hagerstown High as BISFA does not have a sports program.

The Committee inquired whether the same was true for students enrolled at Tech High.

Staff noted that students enrolled at Tech High are able to participate in sports at their home school as Tech High is considered a program.

The Committee questioned why a school such as Eastern Elementary does not need parents to apply for Free and Reduced Meals to receive them.

Staff responded that this question will be addressed at a future meeting.

The Committee noted that St. Maria Goretti School has announced it will close at the end of the 2023-2024 school year. They questioned what/if any impact this may have on enrollment at WCPS.

Staff said that it estimates St. Maria Goretti School has approximately 150 students enrolled. Students from this school reside within multiple school attendance areas (both in and out of state/county) and WCPS does not expect any one attendance area would see much of an increase from this closure.

The Committee noted that Jonathan Hager Elementary is currently at 100% of its state rated

capacity and questioned whether there is a plan to address this.

Staff stated that when Jonathan Hager Elementary was built, it was constructed as a 3-round school (meaning 3 classrooms per grade level). The building was planned/built with core spaces designed to support enrollment for a future 5-round school – meaning 2 additional classrooms for each grade could be added in the future and be supported by the core spaces. Core space is considered areas such as gym, cafeteria, media areas etc. WCPS is monitoring the residential developments and enrollment in the attendance area as well as adjacent areas. This is an example of a capacity issue due to increased housing availability both within the city and county. Avenues for addressing this issue could include redistricting, placing portable classrooms onsite, or a building expansion, pending the funding available.

A Committee member asked if the new Downsville Pike Elementary would provide enrollment relief for Jonathan Hager Elementary.

Staff noted that Downsville Pike Elementary is primarily an inventory/infrastructure upgrade, with two (2) obsolete buildings being replaced with one new building, with only a few additional seats being added. It was noted that this facility would likely not be in the right location to offer significant enrollment relief to Jonathan Hager Elementary. Staff noted that additional developments and other schools in the County/City would likely need the additional seats at Downsville Pike Elementary.

#### III. Discussion of Future FEAC Meetings. FEAC Members, and Meeting Dates

The next meeting of the Committee will likely be held in May 2024 to review and discuss the Educational Facilities Master Plan.

The Committee has multiple vacancies and staff plans to review applications and make recommendations to the Board of Education to fill these vacancies.

It is expected that the Committee may see a request from the board to establish an attendance zone for Downsville Pike Elementary.

#### IV. Adjourn

The meeting adjourned at 7:00 pm.





### **Total Student Enrollment Trends**




