Dear Student/Parent:

Congratulations on your selection into the Cosmetology Program at Washington County Technical High School!

The following information is being provided at this time so that it may assist you when shopping for back to school over the summer, and paying for the junior cosmetology kit.

1. Junior Cosmetology Kit – The total for this year's kit is \$525.42. A non-refundable kit deposit of \$100 is due by August 1st. All kit balances must be paid in full by the fist day of school, unless you have made arrangements for a payment plan. All payment plans must be put in writing and given to me by the first day of school. Payment plans must be pre-approved. Students will not be permitted to take any items from the kit home until the balance is paid in full. For your convenience, kit payments can be made at the school during the summer on Monday-Thursday s between the hours of 8:00 a.m. and 4:00 p.m. You may also mail payments to the school at:

- **Please make certain that you deduct the \$100 deposit from the kit balance.
- 2. Required Forms Please make sure that all forms included in the summer packet are signed by both parent and student, and returned the firs day of Cosmetology. This is very important.
- 3. Supplies The following is a list of supplies that your child must have for the first day of Cosmetology. If you are unable to purchase any of the supplies, please let me know as soon as possible.
- One three-ring binder (At least 2 inches) with notebook paper
- A minimum of 12 subject dividers
- 2 1-subject spiral notebooks
- Pens and Pencils
- 2 boxes of facial tissues
- 1 box of plastic sandwich baggies
- Hand lotion
- Hand Sanitizer

** After students receive their cosmetology kits, they will want to purchase plastic containers for their kit supplies. The Dollar Store and Family Dollar are good places to purchase these containers.

- 4. Dress Code/Attire The Cosmetology Program has a well-defined dress code. We follow the dress code outlined by Washington County Public Schools and the standard dress code for professionals in the salon industry.
- ✓ Dress code for Cosmetology is all black. All clothing must be black with no other color. Attire should look neat, clean and professional.
- ✓ Dresses and Skirts the length of dresses and skirts must be just above the knee or longer. We do a lot of bending and reaching, so everything needs to be covered.
- ✓ Shirts Shirts cannot expose midriff or cleavage areas. They must also cover the entire back and shoulders. No belly shirts or tank tops without a shirt over top will be permitted.
- ✓ Pants Pants must be black. Black jeans are permitted as long as they do not have holes. No blue jeans of any kind.
- ✓ Shoes Shoes should have skid-proof soles. All shoes need to be secured to the foot. Sandals and flip flops without a strap across the heel will not be permitted. Please refrain from wearing high heels. They become uncomfortable when standing for long periods of time and can be a fall hazard.

**The Cosmetology Program follows the dress code of many professional salons, therefore, blue jeans, pants with holes sweat pants, yoga pants, legging/jeggings, sweatshirts or jerseys are not permitted.

Students who do not follow the dress code will be asked to change their clothes. If you are not available to bring in a change of clothes, they will be asked to wear black scrubs that is provided by the program. Not following the dress code will be reflected in the daily grades and could result in further consequences.

The Cosmetology Program for junior students will operate on an A day/B day schedule. This means that students have cosmetology every other day. In order to gain the remaining hours needed for licensure, student will have cosmetology everyday in the senior year.

Each student must meet the following requirements:

Attendance - Class begins each day at 9:05 a.m. and students are dismissed at 3:00 p.m., unless your home school is Hancock High. Hancock students are dismissed at 2:50. The Cosmetology Program has a very strict attendance policy. Any time missed from cosmetology will be counted. This means that if you arrive late, leave early or miss the entire day for any reason, the amount of time missed will be deducted. Since the Maryland State Board of Cosmetology requires 1500 learning hours in order to take the state exam at the end of the senior year, maintaining good attendance in both the junior and senior year is very important. Too much missed time may result in dismissal from the program. Regular attendance in all classes, including academic classes is also expected of cosmetology students.

Credits – Students will earn four credits in their junior year, and eight credits their senior year. Since students must remain in cosmetology every day in the senior year, English 12 and a senior year math must be taken outside of the normal school day. This may be done in summer school, twilight or evening classes. More information regarding options available to cosmetology students will be given at the beginning of junior year. Please refer the the letter provided in this packet by Assistant Principal Scott Buhrman. Students are required to take the Maryland State Board exam in order to receive their cosmetology credits.

Grades – Any student who receives an unsatisfactory grade for Cosmetology I, may not be permitted to proceed to Cosmetology II. Satisfactory grades are expected in all academic classes as well. Failing grades in any class could result in termination of the program. If you are struggling in cosmetology or any other class, please seek additional help.

Behavior – Students are expected to abide by the 'Cosmetology Classroom Behavior Contract'. WCTHS and the Cosmetology Program have a no-tolerance policy when it comes to harassment, bullying or aggressive behavior. Bullying of any kind, including social media, will result in termination from the Cosmetology Program.

Theft – Taking things that belong to the school or another student **will not be tolerated.** Stealing from an employer would result in being fired and taking things in class that do not belong to you may result in dismissal from the program.

Cell Phones - All students are expected to abide by the 'Cosmetology Program Cell Phone Policy'. Failure to abide by the policy will reflect in student's daily grades and could result in a referral to the Assistant Principal.

Cosmetology Kits – A student kit containing implements and materials for use in the course and future employment must be purchased. The kit must be paid in full by the first day of school, unless a payment plan was put in writing and pre-approved. Students will not be permitted to take kit items home until the balance is paid in full. A senior kit will not be ordered until the junior kit is paid in full.

Dress Code – The Cosmetology Program has a well-defined dress code. We follow the dress code outlined by Washington County Public Schools and the standard dress code for professionals in the salon industry. All clothing must be black with no other color unless approved by teacher. Attire should look neat, clean and professional. Hair and makeup should be done prior to coming to class. Please refer to the 'Cosmetology Program Dress Code' contract for more details.

Safety and Sanitation – Students are expected to keep their work stations and desks clean and orderly. They are required to follow the state law in regards to sanitation and disinfection of salon equipment, tools and materials. Students will follow all safety guidelines. Students are expected to participate in daily chores at the end of each day. Chores will imitate the chores performed in an actual salon environment.

Models – Learning activities in the Cosmetology Program require that each student perform as a model and practitioner. Students must experience, practice and demonstrate their proficiency with various procedures required in the Maryland State Board of Cosmetology curriculum. All students will be required to participate in all learning activities.

Note: Every precaution will be taken during these services to protect and preserve the health and well-being of each student.

Licensing Exam - All students who have completed a minimum of 1,500 hours of training will be eligible to take the Maryland State Board of Cosmetology exam at the end of senior year.

Cosmetology I Cell Phone Policy
